The Religious Leaders Forum made a moral commitment to address the issues of warmth and shelter as well as literacy. The Interfaith Leadership Council of Metropolitan Detroit established **The Warmth Project** to implement practical ways to make an impact on this critical community issue. If the DHS payment is insufficient to address need or if your household is ineligible, contact 2-1-1 for additional bill payment assistance options. 2-1-1 will direct callers to (1) agencies with bill payment assistance programs and funding, e.g. THAW, The Salvation Army, Community Action, NCCS, St. Vincent, etc. and to (2) agencies providing related weatherization and energy education, e.g. Community Action Agencies, WARM Training Center, Michigan Energy Options, NCCS, etc.

2-1-1 may also refer to other vital needs services provided by area agencies: rent/housing, foreclosure prevention, food, EITC, State EITC, budget/credit counseling, tax preparation assistance, Link-up/Lifeline phone discounts, etc.

\*If 2-1-1 does not exist in your area, contact your local area assistance agencies individually, e.g., THAW, The Salvation Army, Community Action, NCCS, churches and church organizations, St. Vincent, Accounting Aid Society, GreenPath, etc. Refer to the Michigan Energy Assistance Directory for help finding your area's assistance agencies.

### **Energy Payment Plans**

- 1. **Budget Wise Plan** anyone can sign up to pay energy bills in equal monthly payments; flexible due dates; no late fees
- Shutoff Protection Plan available to anyone with large overdue accounts; no income restrictions; payment plan established to pay past due amounts over a specified monthly payment agreement
- 3. Winter Protection Plan protects seniors 62 & older and low income families from shutoffs between Nov. 1 and March 31; establishes a payment plan

### **SEMCO ENERGY Gas Company Payment Assistance Programs**

SEMCO coordinates with a variety of agencies to offer payment plans and assistance programs to help customers with their gas bills. The most important thing is to contact SEMCO as soon as you know you cannot pay your entire gas bill. We will work with you to set up a suitable payment plan or advise you of assistance agencies in your area. ### Typical Documents Needed to Determine Assistance Eligibility

- Proof of household income
- Valid Michigan ID that matches resident address
- Utility Bills that match client ID and address
- Shutoff, no active service or past due notice
- DHS Decision letter approving emergency assistance
- Bill payment history for past six months

### **Determining "Low Income" eligibility**

Most energy related programs use 200% of federal guidelines for poverty as criteria for providing assistance. Note that State Emergency Relief (SER) and Winter Protection Budget plans use 150% and the State Home Heating Credit uses 100% levels.

#### **Eligibility**

- Account balance cannot exceed \$2500 for combined accounts or \$2000 for single accounts
- A bill/invoice is required for deliverable fuel vendors.
- Applicant must have a valid Michigan drivers License or State ID
- Account must be residential, not commercial.
- Account must be in the applicant's name and he/she must live at the service address.
- Applicant must obtain a State Emergency Relief (SER) "Decision Notice" from Michigan Department of Human Services IF they have a current shut-off notice (except seniors).
- Account must have a past due balance, shut off notice, disconnected service, or have an immediate need for deliverable fuel.
- Applicant must pay unauthorized usage charges.
- Applicant must have paid \$225 on single/\$450 on combined accounts within the past six months.
- Proof of household income is required. Income must be at or below 200% of the current Federal Poverty Level guidelines (see chart below).

#### Income Requirements

To be eligible for THAW assistance income must be at or below 200% of the current Federal Poverty Level (see chart below).

THAW assistance is granted once per calendar year for each utility type.

To find out if you or your client qualifies for energy assistance with St. Vincent de Paul Energy Assistance Program answer these questions:

1. Is the total annual gross household income of all earning members in the family above the age of 18 years, at or below the amount mentioned in the table:

(If YES proceed to the next question. If NO, you do not qualify for energy assistance under St. Vincent de Paul, Energy Assistance Program.)

- 2. Is the total balance of the current energy bill below \$3500 for a combined gas/electric account or below \$2000 for a single utility?
- (If YES proceed to the next question. If NO, you do not qualify for energy assistance under St. Vincent de Paul, Energy Assistance Program.)
- 3. Does the name and address on the energy bill match the name and address on the photo ID?
- (If NO, you need to go either to utility company or Secretary of State so that you meet the above qualifying requirement and complete the pre-screening once this is done.)
- 4. Have you paid (this is not payment made by any agency) more than \$450 for a combined account or \$225 for a single utility in the past 6 months? (If YES proceed to the next question. If NO, you do not qualify for energy assistance under St. Vincent de Paul, Energy Assistance Program.)
- 5 Have you received any energy assistance in the last 12 months from any agency (other than DHS) which is below \$3,000 for combined gas/electric account or less than \$1,500 for a single utility?

(If YES proceed to making a phone call. If NO, you do not qualify for energy assistance under St. Vincent de Paul, Energy Assistance Program.)

If you answered YES to ALL above questions, call phone # 313 393 2930 and follow the prompts to receive assistance. This is only the first step in the application process and is not a guarantee of receiving energy assistance.

If your answer is NO, you do not qualify for energy assistance under St. Vincent de Paul, Energy Assistance Program. However, you may want to approach other service agencies to check if you are eligible under their program.

### **Salvation Army** Energy Assistance

To help make a difference, The Salvation Army serves to resolve immediate crisis as well as "encourage accountability, support long-term sustainability and balance accountability with service."

In combination with state funds, The Salvation Army partners with several Michigan utility companies to offer low-income assistance programs and bill credits.

Begun in 1983, **PeopleCare** is a unique partnership between Consumers Energy and The Salvation Army to help Michigan households who may not qualify for other assistance yet are struggling to make ends meet.

As available, the <u>DTE Match Program – DTE Energy</u> enables The Salvation Army to assist DTE customers who are in shut-off status or have experienced disconnection of service. If a household meets income eligibility requirements and is able to commit a portion of his or her own resources toward their bill, DTE will match The Salvation Army's contribution on the remaining account balance. DTE will then restore service if necessary and place the customer on a budget plan.

### Michigan Community Action Agencies

### **Energy Assistance**

MCAAA provides funding to CAAs who make payments towards client energy bills. For this program we utilize our network of CAAs. The partnerships that exist between CAAs, and state and local MDHS offices, and other community groups have resulted in better coordination of services, thus expanding the safety net that exists in the State of Michigan to include those who may not be eligible for state or county programs. CAAs work with other human service providers in their area as well as utility companies, deliverable fuel providers, and other assistance providers to maximize the services available to the low-income client.

In addition, many CAAs sponsor Walk for Warmth or similar fundraisers to raise money to help low income families pay for heat and electricity. Typically held during the colder parts of the year, Walk for Warmth fundraisers are a great way to involve community supporters, school groups, and others in a positive activity.

### 10 Ways to Save on Winter Heating Bills

- 1. Lower your thermostat to 68 degrees. In the winter, set the thermostat between 65 and 70 degrees during the day and to 58 degrees at night or when away from home for several hours. If you have a heat pump, make sure to slowly increase the temperature to avoid running the emergency heat. You can learn more about your thermostat online by visiting the U.S. Department of Energy website.
- 2. **Seal air leaks.** Seal all holes from pipes and wires that enter/exit the living space. This includes entrances, pull-downs and attic stair openings, light fixtures, pipes and wires. Attic entryways should be weather stripped and insulated.
- 3. Seal off fireplaces. Never use a fireplace as a heat source for your home. Even as a supplemental heat source, the cold air introduced to a warm home through an open flue isn't as efficient as sealing off a fireplace and using the primary source of heat. For natural gas fireplaces, turn off the pilot light when not in use. Seal off the fireplace area or the flue area to prevent cold air from leaking in. (Note: Building codes in some areas require that the damper in your chimney to be permanently blocked open if you install gas logs. Please check the building code for your area for the appropriate procedure.)
- 4. Seal duct work. This is the number one way to conserve energy. Make sure that all ductwork is sealed at joints and intersections with duct sealer or silicone caulk. Otherwise, supply ductwork can leak heated air into the attic or crawl space, and outside air can be drawn into the return ductwork, increasing costs and reducing comfort dramatically. Ducts can be sealed using foil-backed tape or silicon caulking.
- 5. Lower water heater to 120-125 degrees. Many water heaters are automatically set at 140 degrees. Lowering the temperature on your water heater to between 120 and 125 degrees will reduce the amount of fuel needed to heat the water.
- 6. **Change furnace filters every month.** This is the number one reason for furnace breakdowns. Inspect heating and cooling equipment annually, or as recommended by the manufacturer. Have a professional check and clean furnaces once a year.
- 7. **Weatherstrip doors and windows.** Inspect windows and doors for air leaks. If you can see daylight around a door or window frame, then the door or window needs sealing. Air leaks can be sealed with caulking or weather-stripping.
- 8. **Insulate water pipes coming from the water heater.** Insulate the first 3- to 6-feet of cold and hot water pipes near the water heater. Insulating all hot water pipes is not necessary where pipes are located in a crawlspace or attic.
- 9. Add an insulation blanket to water heater. Wrapping the water heater with an insulation blanket can save heating money by slowing the drop in temperature from the hot water tank as it sits unused. Inexpensive insulation kits are available at most home improvement stores.
- 10. **Add insulation to attic.** When adding insulation, start at the top and work down only after eliminating air infiltration.

### Tips to Save Energy & Keep Cool This Summer

Raise your thermostat to 78°. If you are away from home for more than eight hours, raise the thermostat setting and you can expect to see up to a 3% savings on cooling costs for each degree of setback. This is the number one way to conserve energy. This will reduce the amount of energy used to cool your home while you're away. You can learn more about your thermostat online by visiting the <u>U.S.</u>
<u>Department of Energy website</u>.

**Keep shades closed when the air conditioner is on.** Sunny windows account for 40 percent of unwanted heat and can make your air conditioner work two to three times harder.

**Check and clean filters.** Cleaning and replacing air conditioning filters monthly allows the system to run more efficiently.

**Clear attic vents.** If the home has an attic fan, make sure it is functioning properly.

Install ceiling fans and make sure they are blowing down. Don't underestimate the importance of ceiling fans. Moving air over the body provides a cooling effect. The use of ceiling fans can mean savings of around 25% on cooling costs and can make the temperature seem 10 degrees cooler. Most fans have a switch to change the fan direction. Make sure ceiling fans are blowing downward (in a counter-clockwise direction) to send air past your body.

Postpone activities that require hot water and large energy use – such as washing dishes or clothes – to early morning or late evening. This will keep from adding more heat and humidity to the home. Use the dishwasher and clothes washer late in the evening. When used during the day, these appliances produce additional heat, causing your air conditioner to work harder.

Use cold water to wash dishes and clothes. This will save on water heating costs.

**Avoid using the stove if possible.** Consider grilling outside instead.

**Unplug equipment not in use.** Electric chargers, televisions and audio/video equipment use electricity and produce heat even when they are not in use. Running an older refrigerator can use up to three times the energy of a modern one. Unplug any appliance when it's not in use.

**Turn off lights.** Turn lights off when exiting a room. They add to the heat in the home. Consider replacing incandescent bulbs with energy efficient compact florescent lights (CFLs). And remember to recycle CFLs whenever possible.

### **Outdoor Tips**

#### Use energy wisely. Don't forget the outside of your home.

**Take this test**: If a playing card fits the crevice of an outside door or window, you need more weather stripping. Caulk and weather-strip to stop air leaks around windows, doors, exhaust fans and any other place where wires or pipes pass through walls. Replace any caulk that has cracks or is no longer soft.

You can install storm and/or replacement windows, but they may not be the best use of your energy improvement dollars because of their high cost and long payback. A low-cost alternative is 6-mil plastic, which you can use to "make" storm windows. Be sure to stretch it as tightly as you can. If you use these homemade storm windows on the inside of your regular windows and attach them carefully, they can last through several seasons. You can also find homemade kits at home improvement stores.

**Keep out winter air** by covering your window air conditioners tightly on the inside with thick plastic or special air conditioner covers. Weather-strip around the units to block drafts.

**Cover bare ground** beneath your home with a vapor barrier to keep moisture from getting into your home. Polyethylene sheets work well. Since a third of your air conditioner's energy is spent removing moisture, vapor barriers can make a noticeable dent in your energy bills.

If you have a **crawlspace**, open your foundation vents each spring and close them each fall.

**Planning to replace your roof?** Consider roofing materials with reflective coatings and/or choose light-colored roofing to greatly reduce heat absorption.

Carefully plan your **landscaping** to help to reduce your energy costs and increase indoor comfort.

**Plant deciduous trees** like oak, maple, gum, ash and dogwood. They lose their leaves in the winter, letting the sun through to warm your home. In summer, their leaves shade your home. Plant shade trees to the south, since that side gets the most sun.

**Evergreens are effective** for blocking wind. Plant them in a staggered or double line to the northwest of your home.

**Smaller foundation plants** can minimize the loss of cool air away from the house in summer and, in winter, provide additional wind protection.

#### 100 Tips 1 - 25

- Plug home electronics into power strips with surge protection. Turn the strip off when the equipment is not in use.
- In the summer, raise the thermostat to 78 degrees.
- Replace regular light bulbs with ENERGY STAR® Compact Fluorescent Lights (CFLs). CFLs use up to 75% less energy.
- Plant deciduous trees on the south and west sides of your home to block the afternoon and evening sun.
- Be more eco-efficient. Use a mug or glass instead of styrofoam or paper cups.
- Write with refillable pens made from recycled plastic.
- Look for the ENERGY STAR® label on home appliances and products. ENERGY STAR® products meet strict efficiency guidelines set by the EPA.
- Consider electric mowers and trimmers. For smaller yards, try a reel mower.
- Consider solar-powered accent lighting for yard and garden.
- For fax machines and printers, use refillable ink cartridges and recycle old ones.
- Activate your computer's sleep mode when you leave your desk. This reduces electricity consumption to less than 5 percent of full power.
- Install low-flow showerheads and faucets. They're inexpensive, easy to install and reduce energy and hot water use.
- Conserve by only printing what you really need.
- Only wash full loads of dishes in the dishwasher and use the energy-saving setting for the drying cycle (or let dishes air dry).
- Look for a dry cleaning service with "clean and green" processes, including reuse of hangers and garment bags.
- To save on water heating costs, use cold water to wash dishes and run the garbage disposal.
- Carpool or use public transportation. If you own a business, encourage carpooling or allow telecommuting to reduce carbon emissions.
- When building a new home, consider energy-efficient building materials.
- Save water by repairing leaky faucets. Even a slow leak wastes more than you realize.
- Shade air conditioning units with trees or shrubs, helping the unit run up to 10% more efficient.
- Defrost your manual unit freezer regularly. Frost buildup increases the amount of energy needed to keep the motor running.
- Weather-strip and caulk around doors and windows to rid your house of drafts and prevent leaking of heated and cooled air.
- Try to buy items that are reusable or come in reusable packaging and make sure to reuse them.
- Look for natural furnishings that have been or can be recycled.
- Use rechargeable batteries; they can last up to twice as long as disposables.

#### 100 Tips 26 - 50

- Take your lunch to work in a reusable container.
- Install lighting occupancy sensors or timers in rooms that aren't used often.
- Choose energy efficient office machines to reduce costs and carbon emissions.
- Conduct an online home energy audit and get personalized energy-saving tips.
- Repair, seal and add insulation to existing heating and cooling ducts to prevent heating and cooling loss.
- If your primary refrigerator is at least 10 years old, consider replacing it with an ENERGY STAR® qualified model.
- Use warm or cold water for washing clothes and always use cold water for rinsing.
- Seal around holes from pipes and wires that enter or exit your home's living space.
- Consider replacing old windows with new high-performance, dual-pane windows.
- Have your cooling system checked by a professional to make sure it's operating at peak efficiency.
- Add insulation to the attic. Your home should have a minimum R-30 insulation in the ceiling or attic.
- Use dimmer switches or timers on lights.
- Don't keep your refrigerator too cold. The ideal temperature is between 32°-39°.
- Use task lighting when possible. Focus light where it's needed rather than lighting an entire room.
- Use three-way lamps. They make it easier to keep lighting levels low when bright light is not necessary.
- Need a new roof? Choose lighter-colored roofing to reduce heat absorption from the sun.
- Turn off running water when shaving or brushing your teeth.
- Consider using a gas range or oven as they cost less to operate than electric units.
- Vacuum refrigerator coils often to keep the unit running efficiently.
- Consider having a professional energy audit performed on your home or business.
- Thinking about a new car? Consider a hybrid vehicle.
- Make sure your refrigerator door seals are airtight.
- Turn off lights when you leave a room.
- Open crawl space vents to keep air moving and the space dry.
- Place the washing machine near the hot water heater because water loses heat as it flows through pipes.

#### <u>100 Tips</u> <u>51 - 75</u>

- Use a fan to help your air conditioner spread cooled air more effectively through your home without greatly increasing energy use.
- Make sure you've insulated around recessed lights, attic doors and other places where outdoor air can sneak into your home.
- Save on air conditioning by closing supply vents in unused rooms. (Note: If you have a heat pump, vents should be left open.)
- If you have a pool, cover it when not in use to minimize heating costs.
- Always wash full load of clothes or adjust the water level for smaller loads.
- A healthy lawn is like an additional air conditioner, keep the grass green and lush.
- Insulate water pipes coming from the water heater.
- Draw shades or drapes to block sunlight during the hottest part of the day.
- When you'll be away from home for more than four hours, raise the thermostat 5-10 degrees or more.
- Install a programmable thermostat and set it to adjust the temperature throughout the day.
- For bathrooms, hallways or bedrooms consider installing LED night lights equipped with photo sensors to keep them off during daylight hours.
- Wrap your water heater with a water heater blanket, especially if it's in an unheated area of your home.
- Don't let kitchen or bathroom exhaust fans run longer than necessary.
- Use the energy-saving feature on computers, monitors, printers, copiers and other business equipment. Turn them off at the end of the day.
- Save paper, energy and money. Take the time to remove your name from mailing lists for reading materials you don't need.
- Lower your water heater to the optimal temperature of 120–125 degrees.
- Clean or replace furnace/air-conditioning filters every month.
- Dry only full loads of laundry and keep the dryer's lint filter clean so it operates at maximum efficiency.
- Create less heat in your home by drying clothes in the early morning or later in the evening.
- Take showers instead of baths to save water. Use cooler water to save energy.
- Make sure drapes and furniture aren't blocking the air supply vents in your home.
- Clean light bulbs regularly. Grime from cooking and dust can make a light bulb dirty, reducing the light it gives off.
- Use an automatic clothes-drying cycle instead of a timed cycle. Put in the next load quickly to make use of leftover heat.
- Fill a dishpan with rinse water instead of letting the faucet run while you do dishes by hand.
- Need a new dishwasher? Look for ENERGY STAR® qualified models.

#### 100 Tips 76 - 100

- Use a pot or pan that completely covers the stove's heating element. When any part of the element is exposed, you're wasting heat and energy.
- When considering the layout of your kitchen, don't place the refrigerator near an oven or other heat source so it will run more efficiently.
- Lower the thermostat. In the winter, set the thermostat between 65 and 70 degrees during the day and to 58 degrees at night or when away from home for several hours. If you have a heat pump, make sure to slowly increase the temperature to avoid running the emergency heat.
- When cooking small meals, try using a small toaster oven as opposed to a large conventional oven.
- Get the kids to turn off the gaming console electronics when they're not using them.
- Like to fall asleep with the TV on? Put the TV on a sleep timer to save energy when you're no longer awake.
- Close the damper on your fireplace when you're not burning a fire.
- Use a rake instead of a leaf blower to tidy up your yard.
- Take reusable cloth bags with you to the grocery store to carry your groceries home in.
- Use less paper by printing and copying on both sides.
- Keep the oven door closed while cooking your meals. Each time you open the oven door, it drops the temperature 25 degrees, requiring more energy to cook your meal.
- Keep your freezer stocked (with food or even frozen bottles of water).
   Freezers work more efficiently when they're full than empty.
- Get a 'water butt' or bucket to collect rain water which you can later use to water your plants.
- Make an effort to run all your errands at once, eliminating trips back and forth from your home.
- Before you open the refrigerator or freezer door, decide what you want to eat so you're not letting cold air escape.
- Look into online banking and bill paying which could help lower your carbon footprint and save money on stamps.
- Remove your AC window unit at the end of each season to prevent heating loss during the winter months.
- When purchasing holiday lights, look for LED lights because they use less energy than traditional light strings.
- When you purchase your next computer, consider a laptop over a desktop as laptops use less energy.
- When it's warm outside, grill out. Cooking outside keeps the heat outside and the cool air inside.
- Keep your range burners clean (and the reflectors) as clean burners utilize energy more efficiently.
- It takes less energy to reheat meals than when cooking them for the first time. Try cooking larger meals and reheating the leftovers.
- Consider placing solar film on your home windows. This can help keep the hot sun out.
- When boiling water, make sure to place the lid on the pot.
- Walk or ride your bike to work.

Based on your home assessment, your contractor will:

After you decide which upgrades to make, approve your contractor's work plan, sign the contract and customer participation agreement and keep a copy for your records.

The Coalition will explore <u>creative solutions</u> to close the gap between what is affordable for a low-income customer to pay for energy and the actual bill.

The Coalition will engage in advocacy supporting adequate federal funding for the <u>Low-Income Home Energy Assistance Program (LIHEAP)</u> and that Michigan continue to receive its fair share of the allocation among the states.

The Coalition will support continued funding for weatherization assistance.

MCAAA provides funding to CAAs who make payments towards client energy bills. For this program we utilize our network of CAAs. The partnerships that exist between CAAs, and state and local MDHS offices, and other community groups have resulted in better coordination of services, thus expanding the safety net that exists in the State of Michigan to include those who may not be eligible for state or county programs. CAAs work with other human service providers in their area as well as utility companies, deliverable fuel providers, and other assistance providers to maximize the services available to the lowincome client.

In addition, many CAAs sponsor Walk for Warmth or similar fundraisers to raise money to help low income families pay for heat and electricity. Typically held during the colder parts of the year, Walk for Warmth fundraisers are a great way to involve community supporters, school groups, and others in a positive activity.
